# b. "Cities of Tomorrow, Today" – Mike Taylor, CGCIO, FLC Associate Director-Infrastructure

Mr. Taylor informed the membership of new technology that is on the horizon and how far along we have come. He gave an example of how long it took for a race car driver to make a pit stop, from 67 seconds in 1950 to 4 seconds in 2013. Mr. Taylor explained that driverless cars are on the way along with drone service, 3D printing and more accessible prostatic limbs with movement. Mr. Taylor stated that the importance of municipalities being in the know of new technology is because it may require changes to infrastructure.
