# League Attorney Jennifer Ashton, Esq.

League Attorney Jennifer Ashton brought the Hillcrest Prop, LLP v. Pasco County case to the general membership as well as the Florida Attorney General's Address on March 27, 2019. The Hillcrest case focused on federal & state laws regarding land us, and substantive due process rights. Fundamental rights does not include "state created rights." Land use rights, as property rights generally are state-created rights and therefore not fundamental rights, which give rise to a substantive due-process claim.
