6. Legal Report

Legal Counsel Jennifer Ashton updated the board concerning *Mullen v. Bal Harbour Village* (Fla3dDCA2018), dealing with the receipt of an illegal petition and if it must be sent to the SOE, and mentioned that cities have recourse via their own codes and charter if they make contingency plan or ordinance in the event that a situation like this should arise.

7. Executive Director's Report

Executive Director Richard Radcliffe informed the membership that the dues change would only be an increase of \$23 for the smallest & \$389 for the largest cities then notified them of the Installation on May 23rd. He expressed appreciation for the Memberships' continued support of the Home Rule Initiative.

8. President's Report

President James notified the Membership of the proposed new budget for 2018-2019 from the Finance Committee and approved by the Board that included a 2.5% Membership Dues increase for the first time in 4 years after a 2009 decrease. This will result in a \$5,475 increase in the League budget.

Motion and second to ratify the 2019 Palm Beach County League of Cities budget. Motion carries unanimously.

President James, in his final meeting as League President, thanked the Membership for their diligence in support of the Home Rule Initiative through 2018 and encouraged continued vigilance to preserve Home Rule for our cities.

Legislative Advocate Jeff Branch, Florida League of Cities, discussed Home Rule and the approval of the First Responders bill, the veto of Bill 1149 and upcoming beach access legislation. He also mentioned Amendment 1 for Homestead Exemption & the Let Things Work Initiatives.
